(General Information) STANDARD CONDITIONS OF ENROLLMENT

TUITION AND SUPPLY FEE: for all 6 camps will be \$459.00 for a two-week session or \$868 for a four-week session, \$1277 for a six-week session and, \$1686 for an eight-week session The tuition includes all activities available based on location, such as, bowling, volleyball, animal shows, field trips and guest appearances by entertainers. The supplies needed for the various camp programs are **included** in the above tuition fee; the two-week kit has a \$70.00 value and the four-week kit has a value of \$130.00 the six-week kit has a \$190.00 value and the eight-week kit has a \$230 value. These supplies will include the camper's back pack, T-shirt and all of their specialty equipment and supplies needed for their unforgettable and exciting adventure into the worlds of Magic, Science, Animals, Dinosaurs, Theater/Music or Science,.

ADMISSIONS: FunCamps reserves the right to refuse admission to any boy or girl whom the camp may deem to be incompatible with the other campers. It is anticipated that all fees shall be paid prior to the child's leaving for camp. In the event it becomes necessary to collect any sums through the courts, the parents agree to pay all cost of suit including an attorney's fees. Camp is not responsible for personal property.

ALLOWANCES/REFUNDS:

I understand Funcamps has a no-refund policy on camp fees, once camp starts. All fees shall be deemed earned when paid. I understand I will not be issued a refund if my child is dismissed due to disciplinary action based on his/her behavior or misconduct. I understand refunds will not be issued in the event any session is cancelled should the National Hurricane Center broadcasts a "hurricane/tropical storm warning" for our area or for any other weather emergency. In such a case, Funcamps will cancel its program without obligation to make any refund for the duration of the inclement weather. Funcamps does not issue refunds for any day or days your child is not in attendance during the course of the program. Only in the case of extreme medical emergency may this policy be reviewed by the Directors. Make-up days will not be issued either. I understand that any deposit paid at the time of the Camper Application is non-refundable.

In case of accident or illness parent will be expected to pay doctor medical expenses, emergency room, X-ray, etc. Your hospitalization policy should cover this.
